COUNCIL SETS BUDGET TO INVEST IN COMMUNITY

Lingfield Parish Council has set a budget for 2024/25 which increases the investment in the community and plans ahead for projects and bigger items of spending.

The Context

Historically the Council has been setting the precept (amount raised from council tax) rises at below inflation, which has led to it reducing its income in real terms. At the same time, the Council has also increased its spending on things such as managing public space, developing the community pond and installing CCTV, investing in litter picking and allotment management, developing a new website, awarding grants and funding events and projects such as Lingfest, amongst others. The Council was reluctant through the COVID pandemic to raise its precept, or to cut its spending, as it recognised this was an unprecedented time of great need. This means that the Council has funded much of its spending recently by taking from financial reserves. The Council cannot continue to spend from its reserves and must therefore, now replenish these to plan properly for the future. This year (2023/24) the Council set itself a precept income of just £62,400 for the whole year, to cover expected spending of £87,050 – an unsustainable position, but a decision arrived at to try to alleviate the impact on the community of the cost of living crisis and utilities price inflation issues we all experienced last year.

The reserves for the Council serve two purposes:

- An "emergency" or "general" reserve to meet audit and legal requirements. the Council must hold a certain proportion of its expected annual expenditure aside. The Council must increase this figure in 2024/25 by £16,000 to meet these requirements.
- 2. Earmarked reserves a list of future items of spending that the Council knows about and needs to save for over a number of years. These include things like new Christmas Lights, elections, Lingfest and emergency tree works. The Council as identified that it must increase its earmarked reserves by a total of £26,500 in 2024/25.

The Numbers

There is a helpful graphic overleaf which explains where the Parish Council will spend and invest the money it receives from an average household in 2024/25. The Council is increasing its precept income from £62,400 this year to £120,626 next year (starting in April 2024). This means that a D-band household this year pays £31.78 and from April will pay £61.43 for the whole year — an increase of £29.65 per year (or £2.47 a month; 57p a week). While this is a large percentage increase, the actual figure to be paid from April compares moderately with other parishes in the district, which demonstrates just how much Lingfield Parish Council has suppressed rises in the past. For further context, the other rises on the council tax bill from April are: Police & Crime Commissioner up £13.00; District Council up £7.11; County Council up £83.52.

The Future


The Council recognises that any increases in household bills are unwelcome, which is why it has kept increases minimal (and made real-time reductions) through COVID and the cost of living crisis. The rise next year is unavoidable as a result of this, but it will ensure that the Council is able to plan its spending carefully over the long term and should help to avoid any more significant increases in the years ahead.

Summary

Lingfield Parish Council has cut its spending power over recent years by making real-terms cuts to council tax to shield households from the pandemic and the cost of living crisis. The Council must now replenish its reserves and plan for future spend in a sustainable way. The significant increase in the precept next year should enable the Council to plan effectively and to guard against any large rises in future years.
