#### 11.1 Star Fields Appeal

Application 2022/685, Land at The Old Cottage, has been called to appeal for 'non-determination'. Members of the planning committee have agreed to apply for Rule 6 status to enable the parish council to speak at the appeal which will be held in August. The application is to be submitted before 22<sup>nd</sup> May.

**Resolution:** Members ratified the decision to apply for Rule 6 status.

**Action**: The clerk will work with Cllr Lockwood to submit an application and

supporting statement.

# 11.2 Flagpole and Flag

The clerk reported that there is a fault with the flag pole. The internal device which holds the flag in place is failing and causing the flag to drop to half mast.

**Resolution:** Members agreed to delegate expenditure power to the clerk to arrange a repair.
